Subject: Starting of MD (Forensic Medicine) course at ACS Medical College and Hospital, Chennai, Tamilnadu under Dr. MGR Educational and Research Institute (Deemed University), Chennai, Tamilnadu u/s 10(A) of the IMC Act, 1956 for academic year 2020-21 - Permission of Board of Governors - Regarding.

Sir/Madam,

I am directed to refer your proposal for Starting of MD (Forensic Medicine) course at ACS Medical College and Hospital, Chennai, Tamilnadu under Dr. MGR Educational and Research Institute (Deemed University), Chennai, Tamilnadu u/s 10 A of the I.M.C Act, 1956.

It is to inform that a hearing was granted to you before the Hearing Committee constituted by the Board of Governors on 23rd September 2019 and the Hearing Committee decided to recommend for 2(Two) seat(s). The recommendations of the Hearing Committee has been considered by the Board of Governors and it has been decided to issue Letter of Permission for Starting of MD (Forensic Medicine) course at ACS Medical College and Hospital, Chennai, Tamilnadu under Dr. MGR Educational and Research Institute (Deemed University), Chennai, Tamilnadu u/s 10A of the I.M.C. Act, 1956 prospectively i.e. from the academic session 2020-21 for 2(Two) seat students per year till the first batch admitted appears in the final examination of the said course. The Teaching Institution be advised to apply for recognition of the qualification for the additional increased intake at the time of first available examination as per the provision of Section 11(2) of the IMC Act, 1956.

It is also to inform that the Board of Governors further decided that Letter of Permission for Starting of MD (Forensic Medicine) course for seats as per available facilities, with prospective effect i.e. from the academic session 2020-21 at ACS Medical College and Hospital, Chennai, Tamilnadu u/s 10A of the I.M.C. Act, 1956 may be issued after receipt of the documents as mentioned below.

In view of the above decision, the Council has decided to obtain Bank Guarantee/ undertaking/ essential documents for issue of Letter of Permission for starting/ increase in seats for the academic year 2020-21:-

1. The applicant should provide all infrastructural facilities in terms of teaching and non-teaching staff, buildings, equipment and hospital facilities as per Medical Council of India norms.
2. No student should be admitted in the above courses till the formal permission of the Board of Governors is granted.
3. The Private Medical College should provide Bank Guarantee of required amount in favour of Medical Council of India, New Delhi valid for three years from a nationalized/ scheduled Bank as per MCI's norms. However, medical colleges/ institutions governed by the State Govt. are required to furnish only an undertaking to provide funds in their budget till the facilities are fully provided as per time bound programme indicated by them.
